With the feng shui advantage of “leaning against the mountain, facing the sea,” Vinh Hoi is a luxury resort complex that includes hill and beachfront villas, along with numerous world-class amenities such as hotels, spas, restaurants, clubhouses, golf courses, and cultural villages.

The Vinh Hoi complex covers 236 hectares, stretches along 2.7 kilometers of pristine coastline, and is surrounded by two mountain peaks, forming a magnificent valley. 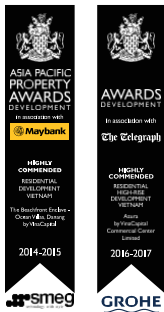
